12. Contents of the complaint / statement of the complainant or informant:

IN THE COURT OF HONORABLE JUDICIAL FIRST CLASS MAGISTRATE, AT KAMAREDDY. Honored Sir/Madam, The facts of the case are that, occurred on prior to 06.01.2026 at 1000 hrs at PMH Colony, Kamareddy and reported on 06.01.2026 at 2030 hrs by the complainant Dusa Ompranay S/o Anjaiah, Age: 29 yrs, Caste: Padmasali, Occ: Business, R/o H.No. 1-4-515/F, PMH Colony, Kamareddy, in which he stated that, with the intention of earning money through trading, he invested funds in a trading website/application known as Xpo.Ru, based on the advice and inducement of persons known to him. Initially, the said persons conducted trading on his behalf and paid him an amount of Rs. 1,70,000/-, thereby gaining his confidence. Subsequently, lured by their assurances that he would earn higher profits, and acting upon their instructions, the complainant transferred money to the Bandhan Bank account provided by them, bearing Account No. 20100035270022, IFSC Code: BDBL0002678. In total, an amount of Rs. 8,90,000/- was transferred through three transactions, the details of which are as follows: 1) On 23.09.2025, an amount of Rs. 3,00,000/- was transferred from his bank account bearing Account No. 24310100025274, 2) On 04.10.2025, an amount of Rs. 90,000/- was transferred through his PhonePe number 9169696677 and 3) On 15.10.2025, an amount of Rs. 5,00,000/- was transferred from his mother's bank account bearing Account No. 34240255077. However, thereafter, the said persons neither provided any profits nor returned the invested amount. The complainant states that some unknown persons, under the guise of trading through the Xpo.Ru website, deceived him by promising high returns and thereby cheated him of a total amount of Rs. 8,90,000/-. Upon realizing that he had been cheated, the complainant lodged a complaint through the 1930 Cyber Crime Toll-Free Number and obtained Acknowledgement Number 33701260000755. Therefore, the complainant requests that appropriate action be taken in the matter as per law.
