Under the express instructions and on behalf of my client namely
Mr. Allen Mechu residing at Vaishali Nagar, Jaipur, Rajasthan - 302021,
I hereby serve upon you this LEGAL NOTICE for your highly malicious,
deliberate, premeditated and unlawful acts of defamation, criminal
intimidation, provocation of public for illegal acts and unauthorized
leakage of confidential court documents. Your vicious and venomous
remarks made against my client on social media platforms (YouTube,
Instagram, Telegram etc.) are manifestly and ex-facie defamatory,

scandalous and calculated to destroy the reputation of my client. Therefore, I issue this stern legal notice and call upon you as under: -

1. That my client namely **Mr. Allen Mechu** is a highly reputable and esteemed individual having impeccable reputation, unblemished character and considerable standing in the society. My client has painstakingly built his reputation through decades of hard work, ethical conduct and dignified living. My client commands immense respect in his professional and social circles and enjoys an untarnished reputation among all sections of society. Any attempt to malign or tarnish my client's hard-earned reputation shall be dealt with utmost severity under law.
2. That it has come to my client's knowledge that you have been brazenly and shamelessly circulating/publishing utterly false, fabricated, baseless and malicious information on social media platforms including YouTube, Instagram, Telegram etc. with the sole and malafide intention of destroying my client's reputation. You have been making vicious public requests and threats aimed at defaming my client without any iota of truth, basis, justification or involvement of my client in any manner whatsoever. Your acts are nothing but a deliberate, calculated and venomous campaign to annihilate my client's standing in society.



3. That due to your aforementioned despicable, malicious and unlawful acts/remarks about my client, my client's reputation has been grievously damaged and irreparably ruined in the society. You have willfully, deliberately and with utmost malice aforethought defamed my client which has completely destroyed my client's hard-earned goodwill, impeccable reputation and honourable standing in the community. Your vicious acts of defamation published on social media platforms which are accessible to millions and wide open for public at large have caused catastrophic and irreversible damage to my client's social standing.

4. That the aforesaid scandalous, scurrilous and venomous remarks made by you against my client and brazenly circulated/published on social media platforms including YouTube, Instagram, Telegram etc., before the entire public are absolutely, patently and demonstrably false, incorrect and fabricated without any semblance of truth and are highly defamatory, libelous, slanderous and calculated to annihilate my client's image and reputation in the society. These vicious remarks were made with clear, malicious and premeditated intention to defame, disgrace, humiliate and utterly destroy the image and character of my client. Due to your malafide and heinous acts/remarks, my client has



suffered catastrophic and irreparable damage to his reputation which has been severely and permanently lowered in the eyes of his community, friends, family circle and also in the general public. The impugned remarks are nothing but a pack of lies designed to portray a completely false, distorted and malicious impression about my client in the society and among all concerned persons.

5. That the widespread and malicious publication of your vicious and defamatory remarks has caused catastrophic, irreparable and permanent injury and total annihilation of my client's reputation and standing. Pursuant to the publication of your scandalous and libelous remarks, my client has been mercilessly questioned, subjected to severe contempt, ridicule, public humiliation and social ostracism. My client has suffered immense and unbearable prejudice and complete destruction of his goodwill, reputation, honour, standing and dignity in the society. The damage inflicted by you is so severe and devastating that it cannot be compensated in monetary terms alone.

6. That your heinous acts of defamation are NOT isolated incidents but constitute a vicious, relentless, systematic and persistent pattern of highly malicious and criminal conduct orchestrated by you. You have been continuously and brazenly spreading utterly

baseless, fabricated and poisonous rumors and false information against my client on various social media platforms including but not limited to YouTube, Instagram, Telegram and other platforms, without any iota of truth or basis whatsoever. These continuous, calculated and venomous acts demonstrate beyond any shadow of doubt your evil and malicious intent to systematically obliterate, annihilate and completely destroy the reputation and standing of my client in the society. Your acts amount to a premeditated criminal conspiracy to ruin my client.

7. That it has further come to the knowledge of my client that you have been deliberately, viciously and with utter malice aforethought provoking the general public against my client by spreading completely false, fabricated and inflammatory narratives and utterly baseless allegations. Your despicable and criminal acts of provocation are specifically and intentionally aimed at inciting, instigating and provoking the public to commit serious illegal acts, violence and criminal offences against my client and to cause grave harm, injury and damage to my client's person, life, property, reputation, livelihood and business interests. Such heinous acts of provocation, incitement and criminal intimidation constitute very serious and cognizable criminal offences punishable with rigorous imprisonment under

the Bharatiya Nyaya Sanhita, 2023 (BNS) and other applicable laws. You shall be prosecuted to the fullest extent of law.

8. That most grievously, shockingly and in flagrant and blatant violation of law, you have committed the extremely serious, heinous and contemptuous offence of illegally leaking and publicly disseminating highly confidential papers and documents pertaining to court proceedings involving my client. These strictly confidential court documents and papers were obtained by you through completely illegal, unauthorized, unlawful and criminal means including theft, criminal breach of trust and/or criminal conspiracy and you have brazenly and deliberately leaked and published the same on social media platforms and to the general public with utterly malicious, wicked and evil intent to cause maximum harm, prejudice, embarrassment and damage to my client and to interfere with and obstruct the administration of justice. The unauthorized disclosure and leakage of confidential court documents is a very serious contempt of the Hon'ble Court and constitutes grave criminal offences including criminal breach of trust, criminal conspiracy, theft and other offences punishable with rigorous imprisonment and heavy fines under law. You shall face severe consequences for this criminal act.

9. That by illegally and criminally leaking confidential court documents and proceedings, you have not only grossly and flagrantly violated the confidentiality and sanctity of judicial proceedings but have also committed very serious, aggravated and scandalous contempt of the Hon'ble Court which strikes at the very root of administration of justice. Such despicable and criminal acts are deliberately and maliciously designed to prejudice and sabotage the pending legal proceedings, poison and influence public opinion against my client, and obstruct, impede and interfere with the administration of justice. Your wicked and malicious acts have caused extremely grave and irreparable prejudice to my client's fundamental and constitutional right to fair trial and have seriously interfered with and obstructed the due process of law. My client hereby reserves the absolute and unqualified right to immediately initiate severe contempt proceedings against you before the Hon'ble Court for your contemptuous, criminal and scandalous acts. You shall be made to face the full wrath of law for your contemptuous conduct.
10. That your aforementioned heinous, despicable and criminal acts constitute multiple serious and cognizable criminal offences punishable with rigorous imprisonment and heavy fines including but not limited to defamation punishable under Sections 356 and

357 of the Bharatiya Nyaya Sanhita, 2023 (BNS), criminal intimidation and threat to cause injury punishable under Sections 351 and 351(2) of the Bharatiya Nyaya Sanhita, 2023, intentional insult with intent to provoke breach of peace punishable under Section 352 of the Bharatiya Nyaya Sanhita, 2023, criminal conspiracy punishable under Section 61 of the Bharatiya Nyaya Sanhita, 2023, and serious offences under the Bharatiya Suraksha Sanhita, 2023 (BSS) and the Information Technology Act, 2000 for cyber defamation, publishing and transmitting grossly defamatory, obscene and offensive content through electronic media. You are also liable for severe punishment for contempt of court proceedings for illegally leaking confidential court documents. You shall be prosecuted for each and every criminal offence committed by you and shall face rigorous imprisonment.

11. That apart from serious criminal liabilities which shall result in your imprisonment, you are also absolutely and unconditionally liable in civil law for payment of heavy damages and compensation for defamation, libel, slander, injurious falsehood, intentional and deliberate infliction of severe mental agony, torture, harassment, and for causing catastrophic loss and irreparable damage to my client's reputation, goodwill, honour, standing and dignity. The quantum of damages, loss and injury

suffered by my client on account of your vicious, malicious, wicked and defamatory acts is conservatively and reasonably assessed at a minimum sum of Rs.20,00,00,000/- (Rupees Twenty Crores only) which is actually a very conservative and modest estimate of the actual, real and enormous loss, damage and injury suffered by my client. You are bound to pay this amount forthwith along with interest and costs.

12. That this legal notice also serves as a STERN, SERIOUS and FINAL WARNING to all other like-minded persons, associates, conspirators, abettors and accomplices who may be directly or indirectly involved or associated with you in spreading defamatory content, vicious rumors, baseless allegations, and confidential information against my client. All such persons are hereby put to STRICT NOTICE that any further acts whatsoever of defamation, provocation, incitement, intimidation or leakage of confidential information shall be met with immediate, severe and stringent legal action both under criminal and civil law without any further notice or opportunity. My client is absolutely and fully determined to protect his reputation, honour and dignity at all costs and shall NOT hesitate to take the most severe and appropriate legal measures against ALL wrongdoers, conspirators and their associates. This is your FIRST and FINAL WARNING.

Any violation shall result in severe consequences including imprisonment and heavy penalties.

13. Therefore, I hereby serve upon you this FINAL LEGAL NOTICE and STRICTLY CALL UPON YOU and DEMAND that you comply with the following within the STRICT timeline specified, failing which severe legal consequences shall follow:

- (a) IMMEDIATELY and FORTHWITH cease and desist from ALL acts of defamation, spreading baseless rumors, provoking public for illegal acts, and leaking confidential court documents against my client with effect from the date of receipt of this notice;
- (b) IMMEDIATELY and within 24 (twenty-four) hours of receipt of this notice, remove, delete and permanently erase ALL defamatory content, posts, videos, messages, comments and material published by you against my client from ALL social media platforms including YouTube, Instagram, Telegram and all other platforms and provide written proof of such deletion;
- (c) Pay forthwith a sum of Rs.20,00,00,000/- (Rupees Twenty Crores only) as full and final compensation for damages, loss and injury caused to my client's reputation, goodwill, honour and dignity within 7 (seven) days from receipt of this notice by way of Demand Draft/Pay Order in favour of my client;

- (d) Within 3 (three) days from receipt of this notice, publish a prominent, unqualified and unconditional PUBLIC APOLOGY on the front page of all social media platforms including YouTube, Instagram, Telegram etc. where you have published defamatory content, and also send such written apology personally to all persons, groups and platforms to whom you have sent, shown or circulated the defamatory content and confidential documents;
- (e) Within 7 (seven) days from receipt of this notice, provide a legally binding written undertaking duly signed and notarized that you shall NEVER repeat such defamatory, criminal and unlawful acts in future and that you shall face contempt proceedings and further legal action if you violate this undertaking. ALL the above MANDATORY actions must be completed STRICTLY within 7 (seven) days from the receipt of this notice WITHOUT ANY FAIL. If you FAIL or NEGLECT to comply with ANY of the above MANDATORY demands within the STRICT timeline stipulated, I have CLEAR, EXPRESS and UNEQUIVOCAL instructions from my client to IMMEDIATELY initiate and prosecute the following SEVERE legal proceedings against you WITHOUT ANY FURTHER NOTICE, OPPORTUNITY or LENIENCY:

- (i) Criminal Complaint under Sections 356, 357, 351, 351(2), 352 and 61 of the Bharatiya Nyaya Sanhita, 2023 (BNS) for defamation, criminal intimidation, intentional insult and criminal conspiracy which are cognizable, non-bailable and punishable with RIGOROUS IMPRISONMENT and HEAVY FINES;
- (ii) Criminal Complaint under provisions of the Bharatiya Suraksha Sanhita, 2023 (BSS) and the Information Technology Act, 2000 for cyber defamation, cyber stalking and publishing obscene/defamatory content through electronic media punishable with IMPRISONMENT and FINES;
- (iii) Civil Suit for recovery of damages of Rs.20,00,00,000/- (Rupees Twenty Crores only) along with pendente lite and future interest @ 18% per annum and full costs on solicitor-client basis;
- (iv) Application for permanent and mandatory injunction with damages restraining you from publishing any defamatory, false or malicious content against my client;
- (v) Contempt Petition before the Hon'ble Court for deliberately and contemptuously leaking confidential court documents and proceedings which is punishable with

IMPRISONMENT for a term which may extend to 6 (six) months and fine which may extend to Rs.2,000/- or both;

(vi) Complaint to the Cyber Crime Cell and Police authorities for registration of FIR against you for commission of various cyber crimes and criminal offences. My client also expressly and unconditionally reserves the absolute right to take ALL other legal actions whatsoever as may be advised, deemed fit and appropriate in law including but not limited to seeking damages for mental agony, harassment, loss of business and livelihood. This legal notice is issued STRICTLY WITHOUT PREJUDICE to all rights, claims, remedies, reliefs and contentions of my client, ALL of which are EXPRESSLY and UNCONDITIONALLY RESERVED. Take notice that ANY SUCH PROCEEDINGS, if initiated, shall be SOLELY, ENTIRELY and COMPLETELY at your OWN RISK, COST and CONSEQUENCES and you shall be held LIABLE to pay ALL damages, compensation, costs, expenses and advocate's fees incurred by my client in pursuing such legal actions. You are further put to STRICT NOTICE that my client shall pursue the legal proceedings with utmost vigour and shall seek MAXIMUM


