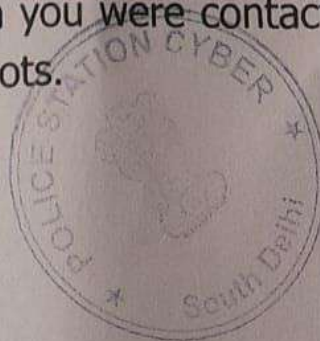

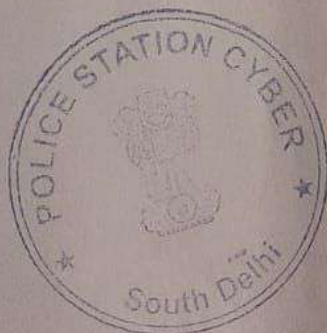

7. Details of any Facebook/Instagram ID/profile/page or any social media platform through which you were contacted or induced, along with profile links and screenshots.



8. Details of the beneficiary bank account(s) to which the defrauded amount was transferred, if known.
9. Whether the mobile phone / banking access (including internet banking/UPI) was solely with you at the time of incident or accessible to any other person.
10. Whether any OTP (One Time Password) was shared by you. If yes, specify the mobile number/platform and the person/entity with whom it was shared.
